Content

The course introduces and aims to train students in sensory design materials and alternative design methods for expression in fashion design. The main content of the course is:

- The basics of the theoretical concepts design and somaesthetics
- Theory and methods for making available the sensory richness of materials and clothing such as sound, tactility, kinesthetics and scent
- Idea and design development based on the relationship between body and material as well as clothing interaction through wearing

Learning Outcomes

After completing and passing the course, students should be able to:

- 1. show understanding of experimental design methodology,
- 2. demonstrate the ability to apply sensory materials and methods as a basis for design development,
- 3. demonstrate basic knowledge and understanding for a theoretical and practical basis of universal design, soma aesthetics and extended fashion practice,
- 4. demonstrate the ability to evaluate and independently reflect on their creative process and artistic development in fashion design.

Forms of Teaching

The teaching of the course consists of lectures, workshops, supervision and seminars, individually and in groups.

The language of instruction is English.

Forms of Examination

The course will be examined through the following examination elements:

- Documented independent creative work (Learning outcomes 1-4) 6 credits Grading scale: Fail (U)/Pass (G)
- Documented written submission (Learning outcomes 4) 1,5 credits Grading scale: Fail (U)/Pass (G)

For the grade passed on the entire course, an approved grade is required for all parts.
